- * record, protect and promote local Aboriginal knowl-

- edge and cultural heritage including to establish a collection of local Aboriginal cultural heritage information that is accessible to the local Aboriginal community;
- * promote the voice and opinions of Walgett Aboriginal
- * conduct programs to promote community unity and improve the relationship between elders and other Aboriginal age groups; and
- * do all things ancillary to the above.



Flexible Overnight Care Proposal

Left: DEG met with Mary Quinlan from Mackillop Services in August 05 to discuss establishing a new service to support community safe-house providers. This strategy will complement the work to establish a safe house for children in Walgett, and will support those which our research found already provide safe-houses for children at risk in the community. During the year the proposal was developed, presented to the Youth Subcommittee, the Interagency and Community Working Party for support, and is yet to be funded.

Mobile PCYC providing a youth activity

Right: Representatives of the PCYC Foundation met with DEG in March 2006 to announce a new mobile PCYC service for Walgett youth four days a month. The Youth Subcommittee takes credit for attracting the PCYC to Walgett and will support the organisation by co-ordinating volunteers and providing advisory services.



Pool Management Plan & heating proposal



Above: In February 2006 Shire Engineer Alan Nelson visited in response to correspondence from the DEG to the Shire Administrator requesting that the Walgett pool be heated by bore water during the winter so that yearround youth programs could be offered there. He undertook to make cursory research and if feasible, will recommend to the Council that a feasibility study be done into the proposal. The need to heat the pool was found in DEG's research with youth and the recognition of the pool's importance in providing over the 2005/06 summer



Walgett's only youth activity. Above: In May 2006 the DEG and the Youth Subcommittee took a key role in negotiations regarding the use of the Walgett Swimming Pool. The need for a pool Management Plan came about because the Walgett Swimming Club was requiring exclusive access to the pool (a community resource located in a Public Recreation Reserve) during the summer on a Friday night despite the youth centre being closed at the time.

DEG produces Welcome to Walgett video



In September 2005 the Dharriwaa Elders Group began producing a cultural awareness video for non-Aboriginal professionals arriving to work in Walgett. The project has many aims, including to improve the services offered to the Walgett Aboriginal community, to promote Walgett's Aboriginal culture and help keep good workers who want to be here. The video script was written by Tim Creighton and Wendy Spencer, and produced



by Heuristic Video Pty Ltd for Dharriwaa Elders Group. The NSW Departments of Education, Police, Attorney General and Health were all involved and modified the script, provided workers and locations for recording scenes depicting new workers coming to Walgett. Dept of Environment and Heritage made a contribution to the costs of the project. We aim for completion in the new financial year.





The Dharriwaa Elders Group made a submission in August 05 to the NSW Dept of Mineral Resources in reply to the department's gazettal of the area known as OPA 4 for opal mining. This area has high conservation and Aboriginal cultural heritage value, and borders on the Narran Lakes Nature Reserve. The submission was made with

legal assistance from Gilbert + Tobin which was much appreciated. The Commonwealth Dept of Environment and Heritage provides DEG with financial assistance to pursue this matter and perform other cultural protection activities.

The Walgett Shire Council Administrator called an EGM in April 2006 to discuss the shire's future. The DEG developed a position paper in discussion with Sam Jeffries, Chair of the Murdi Paaki Regional Assembly, and Virginia Robinson, Chair of the Walgett Community Working Party. DEG Project Manager Wendy Spencer delivered the presentation on behalf of the Chairperson of the Walgett Community Working Party who couldn't attend. Most of the recommendations of our presentation were incorporated into the final recommendations of the Administrator, ie:

"Recommendations:

That the Minister for Local Government be asked to consider deferring the scheduled election of the Walgett Shire Council to give the Administrator of Walgett Shire the opportunity to consider and/or investigate the options for fu-



ture strategic direction outlined in this report.

That the Minister for Local Government be requested to develop a suitable mentor role to site in Council meetings for a period after general elections to ensure that Councillor and staff meet the requirements of the Local Government Act.

That the Walgett Shire Council participate in the Murdi Paaki Regional Assembly modelling exercise

That a long term campaign to ensure that Aboriginal people participate more fully in Local Government be developed.

That the Minister for Local Government be advised that the Community Working Parties are the recognised governance for the Aboriginal communities of the Shire as per the COAG agreement. Carried."

DEG contributes to Review of NSW Aboriginal Land Rights Act



Dharriwaa elders attended and opened a community consultation organised in November 2005 by the Department of Aboriginal Affairs about the progress of the governments review into the NSW Aboriginal Land Rights Act. *DAA's Jodi Broun introduced the day, and Jack Beetson*

DEG works to improve Walgett services

Dharriwaa Elders Group Incorporated





In March 2006 members of the DEG, NSW Education and other community education stakeholders, met with Linda Burney MP and John Lester from the Dept of Education to evaluate and improve the progress of the Walgett Community College.

The job description and duties were decided. DEG requested that it provide office facilities to the position (in order that community development initiatives share resources) but this offer was rejected. The lack of a community facilitator position all financial year appears to have severely hampered the community development progress of Walgett, when compared to the progress of other communities who have had a stable position. The DEG performed a similar, yet mostly unrecognised role in Walgett in its absence.
