Speaker's Annual Report to Dharriwaa Elders Group ("DEG") members for 1 July 2018 – 30 June 2019.

#### **Members News**

From 1 July 2018 – 13 December 2018 the following Elders Councillors presided: Speaker: Clem Dodd, Secretary: Virginia Robinson, Treasurer: Richard Lake. Elders Councillors: Gladys Walford, Violet Morgan, Elizabeth Peters. At the 13 December 2018 AGM the following were elected: Speaker: Clem Dodd, Secretary: Virginia Robinson, Treasurer: Richard Lake. Elders Councillors: Paul Winters, Margaret Barden. After the AGM Full Members Violet Morgan, Lewis Beale, Elizabeth Peters were invited to join the Elders Council to fill casual vacancies. During the period DEG's Elders Council secretariat prepared and held 10 meetings. DEG contributed food vouchers to 17 families for Walgett funerals during the period.

#### Representation

**Narran Lakes Co-Management Committee.** Virginia Robinson represented the Dharriwaa Elders Group on this committee, which was managed by the NSW Office of Environment and Heritage. Her reports were made as regular agenda items of DEG meetings and correspondence and business arising were addressed when DEG delegates were made aware of the Committee's business.

**ACHAA.** Clem Dodd and Wendy Spencer represented DEG in its role as a committee member of Aboriginal Cultural Heritage and Arts Association (ACHAA), attending meetings by phone from Walgett, and bi-annual gatherings in person when resourced.

The Objects of Dharriwaa Elders Group continue to be implemented by the organisation. The Yuwaya Ngarra-li partnership with UNSW is providing financial, human and knowledge resources to support most objectives. The Department of Health's CHSP program supports an important part of the organisation's efforts. Our participation in the Royal Commission into Aged Care has illustrated how ground-breaking and important our holistic model of care for healthy ageing is. DEG's role in managing and growing Aboriginal cultural values and knowledge remains under-recognised but will continue. DEG continues to network with similar Aboriginal cultural organisations in our NSW peak body ACHAA (Aboriginal Cultural Heritage and Arts Association) to grow our strengths in this unsupported and undervalued domain. Our work advocating a different approach and role for governments, particularly in DEG's reply to the draft NSW Aboriginal Cultural Heritage Bill, and our experiences with the implementation of the NSW Government policy for Aboriginal Affairs Ochre including Local Decision-making and Connected Community Schools creates trauma in our relationships with NSW agencies and has alerted the organisation to impending NSW government interventions we will be forced to navigate. The Commonwealth Government is absent from any Aboriginal Cultural and development work undertaken by DEG. Local government is awakening to potential economic benefits from Walgett's Aboriginal cultural knowledge and values, yet shows little support for organic growth of grassroots Aboriginal cultural development. DEG's leadership faces a difficult year as it seeks to bring benefits to the Walgett community with its influential partners. We share highlights of our work during 1 July 2018 – 30 June 2019 in the following pages of this report.

#### Yuwaya Ngarra-li "vision"



Yuwaya Ngarra-li (YN) is a community-led partnership between the Dharriwaa Elders Group (DEG) and the Univesity of NSW.

Professor Eileen Baldry, Deputy Vice-Chancellor Equity, Diversity and Inclusion, is the Academic Lead of Yuwaya Ngarra-li. The core Yuwaya Ngarra-li ("YN") team is based in Walgett and UNSW Sydney. At UNSW Sydney, Yuwaya Ngarra-li sits within the Institute of Global Development.


The purpose of Yuwaya Ngarra-li is for the Dharriwaa Elders Group and UNSW to work in partnership to improve the wellbeing, social, built and physical environment and life pathways of Aboriginal people in Walgett through collaborating with government, philanthropy and community organisations on evidence-based initiatives, research and capacity building, and to evaluate this model of CommUNIty-Led Development as a way of working with other Aboriginal communities.

Wendy Spencer (DEG Project Manager) is the Yuwaya Ngarra-li Walgett Partnership Manager, Peta MacGillivray is the Yuwaya Ngarra-li UNSW Partnership Manager, Vanessa Hickey is DEG's Yuwaya Ngarra-li Project Officer and Ruth McCausland is Yuwaya Ngarra-li Research & Evaluation Director. We are proud of our team's capabilities and look forward to working with colleagues and stakeholders who support and understand our approach.

The DEG has identified the following long-term aims for Yuwaya Ngarra-li in Walgett:

- 1. Greater Aboriginal community control and capacity
- 2. Increased numbers of Aboriginal young people in education, training & employment
- 3. Reduced numbers of Aboriginal people in contact with the criminal justice system
- 4. Improved social determinants of health and wellbeing amongst Aboriginal people
- 5. Improved sustainability of energy, water, land and natural resource management
- 6. Redirection of government funding towards strengths-based, holistic, community-led and sustainable initiatives

The partnership is developing and testing a new model of 'CommUNIty-Led Development' which is a place-based approach to breaking the cycle of systemic disadvantage, centring the needs and priorities of Aboriginal people through the leadership of a respected local community-controlled organisation and drawing on the expertise, influence and resources of UNSW. The diagram top right is our approach to this model in Walgett.









Aboriginal Cultural Heritage and environmental management



# Water learning and advocacy

DEG continues to express alarm about the impacts on Walgett's wellbeing from the mismanagement of water in the Murray Darling Basin. Through our Yuwaya Ngarra-li partnership with University of NSW, we have sourced experts to inform the Walgett community about our drinking water, and why the high sodium in our water is concerning. We urge water decision-makers to start prioritising health and wellbeing and sustainable industries for thriving futures for communities in western NSW. Our rivers, the lifeblood of our community, have been grossly mismanaged given our changing climate, and water saving measures have not been put in place. Walgett means 'the meeting of two rivers', the Barwon and Namoi, and yet no water currently flows in those rivers at Walgett. The town's drinking water supply is coming from the Great Artesian Basin since the Namoi River has dried up. We have held significant concerns for some time about the high levels of sodium in this bore water and the serious implications for a community with high levels of chronic disease, informed by world experts who have tested Walgett's drinking water. Long term use of bore water in the drinking water system is neither a safe or viable solution for Walgett.

Our concerns were realised when Walgett's drinking water supply was jeopardised over the January 2019 new year period after a breakdown at the local treatment plant, leaving the water levels in the reservoir at critical levels and Walgett Shire Council urging residents to conserve filtered water for drinking. With temperatures reaching well over 40 degrees, some residents were also left without air conditioning after evaporative air conditioners could not operate. Concerned people from across NSW donated bottled water to Walgett residents, in a moving display of generosity and shared outrage that Walgett could be so vulnerable to losing its water supply.

Water and related issues are a priority for the Yuwaya Ngarra-li partnership. As part of the long-term commitment to Walgett through Yuwaya Ngarra-li, UNSW Engineering's IMPACT Engineers and the Global Water Institute were invited by DEG to visit many months ago to scope water projects, including new infrastructure, training and long term capacity building.

The YN team developed and provided an induction program for the students in Sydney and then with Elders in Walgett. While in Walgett the team were invited to scope water projects for the Walgett Aboriginal Medical Service's Community Garden, and the provision of Drinking Water Kiosks. ### Water engineering capability

DEG has long held concerns for the health of surface and ground waters of Walgett. The DEG understands the cultural significance and vital importance of water to the Social and Emotional Wellbeing of the Walgett Aboriginal Community.

Over its 20 years of operation, DEG has become increasingly aware of the vulnerability of Walgett's water infrastructure and capacity, and the lack of planning for the impact of climate change. The DEG is also aware of the low priority that the views of the Walgett community are given in planning for water security.

Global Water Institute Engineers Greg Leslie, Martin Andersen and Melinda Wimborne who support student-led projects were invited by Dharriwaa Elders Group to look at a range of Walgett water engineering challenges in September 2018. Walgett Shire Council's Mayor and Deputy Mayor and the Council water team and engineers supported the parts of their visit which required understanding of current facilities and practices. We were pleased to assist Walgett Aboriginal Medical Service to think through their responses to the Walgett water restrictions, for Walgett's valuable local food assett - the community garden. During the visit we secured a donation of Great Artesian Basin water from the Council to fill the 1 x water tank at the garden - a temporary solution. We are following up with obtaining expert opinions regarding the length of time artesian water should be relied upon, and designing ways to obtain permanent water security for this important community food resource. Dharriwaa Elders Group first hosted "Impact Engineers" in Walgett in February 2019. This is a multi-disciplinary team of students who work together to make an impact. They provided desalination for a Sri Lankan village and through Yuwaya Ngarra-li they are working to make the WAMS Community Garden more water efficient. Their second visit to install trial waterefficient garden beds was in June 2019 when IGA burnt down.



DEG hosted collaborators in the UNSW Built Environment Faculty - Sara Padgett Kjaersgaard & Louise McKenzie in Walgett mid-February 2019, scoping many future Yuwaya Ngarra-li community-led projects. Sara Padgett Kjaersgaard took heat images of various places Walgett children and young people use, and at the end of their visit DEG and YN staff workshopped project priorities with staff of Walgett Aboriginal Medical Service.



Elders inducted Assoc. Professor Jacqui Webster and Keziah Bennett-Brook to Walgett in February 2019 and DEG discussed future potential public health, preventative health community-led projects, together with Walgett Aboriginal Medical Service. Jacqui and Keziah work with the George Institute for Global Health and are collaborating with us to find the resources and evidence base we need to implement aspects of our Action Plan for Children and Young People, launched in 2018.





Impact Engineers from UNSW Global Water Institute, with Ernie Sands from WAMS installed 2 x water efficient test garden beds in the Walgett Aboriginal Medical Service ("WAMS") Community Garden, for WAMS' Sophia Byers in early June 2019. Unfortunately these test beds did not work in the drought conditions and so Test #2 beds are to be installed in September 2019 when the students return.



Yuwaya Ngarra-li Walgett Food Forum

> 8th April 2019 FORUM REPORT

Yuwaya Ngarra-li hosted the Walgett Food Forum - "Food and Water is Life!" 8 April 2019. Read our statement here and report released 26 June 2019 here.

The Dharriwaa Elders Group identified the need to improve access to available affordable nutritious food in Walgett as a priority for Yuwaya Ngarra-li from key community concerns raised in our *Community Data Gathering in December 2018* and in our community consultations and workshops developing the *Action Plan for Children and Young People* in April and May 2018. These concerns include:

- the lack of affordable healthy food options and social places to eat is having an adverse impact on health.
- the degradation of the rivers over time and the most recent rapid stopping of flow have had increasingly devastating effects on sources of food.

To learn from and act on these community concerns and perspectives, the aims of the Yuwaya Ngarra-li Food Forum were to:

- Provide data and research about what is known about food issues relevant to Aboriginal people in Walgett and impacts on long-term health and wellbeing
- Gather community members and critical services, organisations, and other stakeholders together to discuss food issues in Walgett
- Facilitate a public forum that is action oriented and focused on positive strategies and evidence-based solutions.

Continuing our work "Food and Water for Life" with Walgett Aboriginal Medical Service (WAMS), Dharriwaa Elders Group's Yuwaya Ngarra-li partnership with UNSW hosted a "water update" meeting 22 May 2019. Speakers included Christine Corby OAM CEO of Walgett AMS, Professor Greg Leslie of UNSW Global Water Institute, Vanessa Hickey of Dharriwaa Elders Group (DEG), Wendy Spencer of DEG, and Roy Butler NSW MP for Barwon. Updates were given regarding the work of the Walgett AMS and DEG to advocate for short, medium and long term solutions for Walgett's drinking water quality, their work distributing packaged water, advocating for improved health & emergency response communications, desalination and other public health solutions including drinking water kiosks, river health and improved river management. Professor Greg Leslie explained how a town desalination system would work and his progress on the design of chilled public drinking water kiosks. He also gave a brief explanation of how Walgett's waste water could be recycled and offered to provide project advice and documentation for necessary approvals. Christine Corby also provided an update on the work WAMS is undertaking with Yuwaya Ngarra-li partners from Engineering and Built Environment faculties to revitalize Walgett's Community Garden - an important community assett that has been wiped out from lack of water. Barwon MP Roy Butler rang in to the meeting from the road to Broken Hill and provided support for our work, saying he is making representations to the NSW Water Minister urging a greater response to the Barwon communities' short, medium and long term water needs, stating that "we need to make the government realize that water is the highest priority issue for our communities". Local agronomist Greg Rummery presented the 10 priorities for Walgett's water security that have been recently identified by community meetings he has been convening.




The meeting agreed unanimously to a statement that was sent by Dharriwaa Elders Group letter to the Walgett Shire Council 24/5/19 which offered support to the Council to enhance Walgett's civic infrastructure by installing and maintaining town desalination and 11 drinking water kiosks to be located in high public use areas around the town, (locations specified). Discussion in the meeting ranged from the impact on rainfall and river health of excessive landclearing, to the need for community education campaigns regarding water efficiency and the use of the drinking water kiosks. Strategies for beginning long-term climate resilience planning by our community were also discussed.

In September 2018 Yuwaya Ngarra-li undertook an audit of Walgett's waste to progress our project to start-up a waste social enterprise. PhD candidate Makrita Tanayian Solitei from Wollongong Uni led the audit, ably assisted by **Walgett Waste Station** workers and Jess McDonald, Walgett Shire Council's Manager of Planning and Regulatory Services. DEG was supported in this activity by Netwaste. The audit gave us all insights into the work needed to improve the waste quality and the quantities of different materials currently going to landfill. Our next step is to prepare our business cases for the two social enterprises Yuwaya Ngarra-li aims to create (led by Dharriwaa Elders Group) which will reduce waste going to landfill and create jobs. Wins for the whole community we hope.



## NSW Aboriginal Culture, Heritage and Arts Association Inc. (ACHAA) – DEG's NSW peak

The AGM of NSW Aboriginal Culture, Heritage and Arts Association Inc. was held Friday 26 October 2018 at the Australian Museum Sydney. Dharriwaa Elders Group attended the AGM by Skype, when Speaker Clem Dodd was re-elected as a committee member. A 2 day meeting was held for the delegates, at which information was shared from NSW Aboriginal Affairs Healing Unit and Languages Team, Arts Law Centre of Australia / Artists in the Black, NSW Aboriginal Tourism Operators Council. Members undertook a planning session for ACHAA and discussed Create NSW assessment of the NSW Aboriginal Arts and Cultural Strategy 2015 – 2018.

2018 Imagine ACHAA Award for Excellence by an Aboriginal Curator - Bianca Beetson for her work curating the New England Regional Art Museum: Myall Creek and beyond exhibition. "The Art Museum along with The Friends of Myall Creek Memorial, Armidale Aboriginal Keeping Place and University of New England produced a program of exhibitions, public programs and a symposium that explored the history and on-going impact of the 1838 massacre of Aboriginal people at Myall Creek. Bianca Beetson was engaged as a guest curator to develop the curatorial direction of the NERAM exhibition. In this role she was responsible for selecting artists to, firstly participate in research residencies at the Memorial and surrounding region, and secondly produce new works responding to the history and site."

In March 2018 DEG joined other ACHAA members at our meeting in the State Library of NSW 7 & 8 March 2019. Workshops to enhance members' capacity included re funding, collection management, community language project development. Overviews were given of the SLNSW language and family history collections.

ACHAA throughout the period offered DEG and other members the opportunity to advocate together for individual organisation's interests and for the Aboriginal Cultural Heritage and Arts sector as a whole.

#### **Dharriwaa Elders Group sustainability and supporters**

DEG staff (part-time and casual) this year were Vanessa Hickey, Robyn Morgan, Wendy Spencer, Clem Dodd, Virginia Robinson.

Efforts to build the capacity of the Dharriwaa Elders Group (an Aboriginal Walgett community cultural organization of 20 years standing) were continued during the period. Services the DEG offers to governments and external NGOs now attract fees. During the period the DEG became stronger in rejecting advances from entities who want to use DEG's assetts but do not serve DEG's priorities or enhance DEG's capabilities. We also became stronger in controlling the way research is conducted in Walgett, and continued to assert community sovereignty over its own data. The wellbeing of our members and safety of staff remains our highest priority and the skill in providing a safemeeting place and harmony amongst Elders and their visitors has become an increasing challenge in our troubled community.
